## TEAM POLICIES

---

1. All players interested in Victory Girls Lacrosse must tryout if they did not participate in the previous season. Prior team tryout or previous team membership (beyond one season) does not guarantee future team membership.
2. All players must sign Player/Parent Commitment Agreement upon acceptance to the Victory Girls Lacrosse Club. This agreement stresses the importance of attendance at practices and tournaments. Victory Girls Lacrosse requires participation at practices and tournaments. CLUB LACROSSE is not casual lacrosse AND the parents and players must be willing to make an ongoing serious commitment. Excessive absences will result in a meeting between the player,

parent, coaches and club director and may result in removal from the team. More than three unexcused absences are deemed to be excessive.

3. Victory Girls Lacrosse teams are divided by student-athletes' years of graduation. At the present time, there is one full team in each year of graduation. There are times when "A" and "B" teams are formed when deemed necessary. It is expected that all players attend all of the scheduled practices for their year of graduation. It is the responsibility of the player to notify the Victory Girls Lacrosse Director by email and CC their direct coach why they were unable to attend. Practice schedules for all years of graduation are available on each team page at [www.victoryeventseries.com](http://www.victoryeventseries.com) and will be communicated via LeagueApps. In the event of inclement weather or changes in the practice schedule, families will be notified via the League Apps and Twitter ([@VictoryGirlsLax](https://twitter.com/VictoryGirlsLax)).
4. Victory Girls Lacrosse coaches expect responsibility and accountability. We hold players accountable for their actions and decisions. Players are instructed to handle all communications with their coaches. That said, coach and parent interaction is encouraged and welcomed in a mature and responsible manner. Victory Girls Lacrosse adheres to the 24 Hour Rule – parents are not permitted to approach a coach until 24 hours after the game.
5. Victory Girls Lacrosse Players are not permitted to join or commit to other travel lacrosse programs that interfere with their participation in Victory Girls Lacrosse. If Victory is attending a given tournament, Victory players attending the tournament must play for Victory Girls Lacrosse.

## TOURNAMENT PROCEDURES

---

It is expected that players attend all tournaments. Please understand that to take a spot on a team and not take attendance seriously is unfair to both your coaches and teammates.

**Important Note for Victory Girls Lacrosse High School Players: Should a conflict arise between your high school team (i.e. game schedule or playoffs) and a Victory tournament or practice, the commitment to your high school team will always come first.**

1. Club registration must be completed online ([www.VictoryEventSeries.com](http://www.VictoryEventSeries.com)) and are scheduled two times per year: fall and summer. All players are required to complete club registration online by the designated deadline. Club dues are paid online or through a mailed check and should be completed by each installment deadline.

**NOTE:** Registration after deadline will only occur if space is available on the roster. Players will not be allowed to participate in tournaments until payment has been received in full.

2. All travel, hotel accommodations and uniform costs are the responsibility of the player's family. Details concerning hotel blocks will be provided to player's family as soon as it is available. Additional tournament information (schedule, roster, and waiver) will be posted on VictoryEventSeries.com and League Apps as well as emailed as soon as it is available.
3. Tournament schedules will be available 2-5 days before the tournament if possible. Tournament schedules will be emailed and posted by director/coach or team manager on League Apps as soon as information from the tournament is available.
4. Player arrival at the field for tournaments is up to the discretion of the coach. Players should be prepared to arrive one hour before their first scheduled game and thirty minutes before each subsequent game. Players should be in full uniform and should travel to each tournament with 2 uniform shirts, kilt and practice pinny.
5. All players will receive playing time. The amount of time played will be at the discretion of the coach. Understanding the goal of attending true recruiting tournaments, the coaches will attempt to give all players an equal share of game time. Victory Girls Lacrosse attends tournaments of a wide variety of competition levels. The goal and format of each tournament can range from pure fun and participation to recruiting exposure and championship formats. At highly competitive tournaments, it benefits the entire program for our teams to perform well. In those situations, playing time, at the discretion of the coach, will be determined with the focus on winning and remaining competitive with the opponent.
6. Victory Coaches are assigned to specific teams for the entire season. Coaches value the player and parent's ability to adapt to different coaching style as they transition from season to season. d

## **Tryout Fees, Club Dues and Refund Policy**

Victory Girls Lacrosse tryout fees are **non-refundable**. Dates will be determined for tryouts within the previous season.

Club dues will be collected semi-annually for the participation in each fall and/or summer season. Dues pay for tournament entry fees, insurance, field rentals, equipment, coaching fees and travel, administrative fees as well as any extras, special instructors, team events. Club dues do not cover uniforms and hotel and travel expenses for tournaments.

Deposit of club dues is **non-refundable**. The remainders of the payments are refundable up to a specific date. This date will be posted at the beginning of season registration. In case of injury in season, refund or credit (minus the deposit) will be determined on a case by case basis.
